JuJitsu is included in Asian Games, Asian Indoor Games and Asian Beach Games and never been so close to be IOC recognized which will give new horizons to our sport. European JJ Union, Pan-American JJ Union and African JJ Union, with the help of JJIF and especially of JJAU should apply to their Continental Olympic Councils to be recognized and participate in the corresponding Olympic Continental Games.

Looking to the above summary we may think that everything is in the right direction and maybe this is true, but is only one point of view, if we look more carefully we will see that we are trying to manage four (now five) continents without actually being able to support JuJitsu development in balance and control all over the world. I am sure that in the years we are members of JJIF, JJIF Board or Commissions, many times all of us think about these problems trying to find how to eliminate them and be more global as an international sport federation and I am sure that many ideas were worked out in our minds, but the expected result never come, why?

It is that some persons are using the sport and JJIF in order to work with clubs in their countries for their benefit only?

It is that some persons are trying to keep a kind of power and control hide behind the “legal” and the “democratic”, believing that they are the only experts in this world?

It is our weaknesses to cross check the real situation in the countries if they are developing the sport or they are using the membership status to put their name in the top and collect money by giving fake belts and fake seminars?

It is our week financial situation that is holding the JJIF down?

All of the above are exist like a disease that is destroying the healthy part of JJIF and you can add many more. Do we have a way to overcome those problems?

An international federation should be consisting by real national federation members recognized and approved by their national sport authorities (NOC or Sports Ministry); it should be organized and structured in a way that the highest sport organization approve, and this is IOC; it should organize administration, marketing and media in a professional way to increase the yearly budget because money is the only fuel to move the engine and the visibility of the sport is tightly connected to that.

I have not the mechanism and I cannot do that in short time (I try the last two year with the JJIF Convention, but many members show no interest or were absent on purpose) therefore having the support almost of the absolute majority of the countries and in accordance with the Point 7.1.3. Of the JJIF statutes I invite all members of JJIF (full and provisional) to participate in an **extraordinary General Assembly at 19<sup>th</sup> November 2015 in Bangkok/ Thailand.**
